## Introduction

See other talks for justifying potential models as a limit of the exact QCD dynamics.

Born–Oppenheimer type of approximation: many other degrees of freedom (light-quark pairs, gluons) integrated out. The heavy Q and  $\overline{Q}$  evolve in a effective potential, sum of their direct interaction and the energy of the gluon field.

In this limit: Fictitious world with simplified quark dynamics: static potential with flavour independence and non-relativistic kinematics.

Many regularity patterns of the spectrum reproduced from the properties of Schrödinger equation.

Dramatic progress on the Schrödinger equation with confining and flavour-independent forces.

Applications to other fields, in particular Atomic physics. Here, also, the same potential is experienced by different masses  $(e^-, \bar{p}, \mu^-, ..)$ .

Already some results for relativistic equations, or spin-dependent forces.

### **Charmonium spectrum-1**

#### Level order 1

E(1P) < E(2S) observed in quarkonium. Notation  $(n, \ell)$ : the radial wave function has n - 1 nodes, the principal number of atomic physics is  $n + \ell$ .

Coulomb theorem  $E(n+1, \ell) < E(n, \ell+1)$  if  $\Delta V > 0$ , the reverse if  $\Delta V < 0$ .

Note: Gauss theorem:  $\Delta V$  indicates whether the charge Q(r) seen at distance r increases (asymptotic freedom), decreases, or remains constant (gravitation or electrostatics).

Klein–Gordon equation. Theorem extended on one side.

Also E(1D) > E(2S) observed.

H.O. theorem

H.O. degeneracy  $E(n + 1, \ell) = E(n, \ell + 2)$  broken according to the sign of  $d^2V/d(r^2)^2$ .

#### **Phenomenological potentials**

These results explain why potentials with different functional dependence reproduce the main features of the spectrum:

-  $\chi$  states below  $\Psi'$ 

- 
$$\ell = 2$$
 states ( $\psi''$ , etc. ) above  $2S(\psi')$ 

Among these potentials: the famous Coulomb + linear

$$V(r) = -\frac{a}{r} + br + c.$$

or more sophisticated : A.F.  $a \rightarrow a(r)$ , screening of confinement, etc.

or simpler

$$V(r) = A r^{\alpha} + B, \tag{1}$$

with  $V = a \ln r + b$ , for  $\alpha \to 0$ .

In ordinary M.Q., two canonical problems:

- ★ # 1. Reconstruct the radial potential from the bound states and the phase-shift  $\delta_{\ell}(E)$  from E = 0 to  $E \to \infty$ .
- ★ # 2. Reconstruct the central potential from the phase-shifts  $\delta_{\ell}(E)$  at given E from  $\ell = 0$  to  $\infty$ .

Several attempts: Thacker, Quigg, Rosner; Miller and Olsson, McWilliams, etc.

Have adapted the formalism # 1 to the case of confining interaction.

Reproduce the current potentials within the uncertainties.

The  $Q\bar{Q}$  game becomes more interesting if the same potential is used with different masses.

Anticipated by Eichten and Gottfried, etc. Became hotter when  $\Upsilon$  and excitations discovered (Lederman).

A first consequence of flavour independence:

In a given potential, deeper binding for heavier mass

This explains

– why first levels of  $Q\bar{Q}$  below the Zweig-allowed threshold  $(Q\bar{q}) + (\bar{Q}q)$ 

- why  $b\bar{b}$  more deeply bound than  $c\bar{c}$ , while  $b\bar{q}$  very similar to  $c\bar{q}$ : more  $b\bar{q}$  bound states expected and seen!

Several successful fits of both  $c\bar{c}$  and  $b\bar{b}$  spectra: Coulomb-plus-linear, Logarithmic, power-law potentials, etc.

This shows that data do not contradict flavour independence.

Also E concave function of the inverse reduced mass

 $(b\bar{c})>(b\bar{b}+c\bar{c})/2$ 

Upper bound also with mild restrictions on V(r).  $dE/d\mu^{-1} = \langle \mathbf{p}^2 \rangle / 2$  can be controlled along its way from  $(b\bar{b})$  or  $(c\bar{c})$  to  $(b\bar{c})$ 

Thus

$$\begin{aligned} (b\bar{c}) &\leq \frac{(c\bar{c}) + (b\bar{b})}{2} - \frac{9}{8}\delta E(c\bar{c}) \left[ 1 - \left(\frac{m_b + m_c}{2m_b}\right)^{1/3} \right] \\ &+ 2\delta E(b\bar{b}) \left[ \left(\frac{m_b + m_c}{2m_c}\right)^{1/3} - 1 \right], \end{aligned}$$

resulting into

$$6.26 < (b\bar{c}) < 6.43 \text{ GeV}$$

Simpler upper bound

$$(b\overline{c}) > (b\overline{s} + (c\overline{c}) - (c\overline{s}) \simeq 6.52 \text{ GeV},$$

while experiment not yet conclusive

$$(b\bar{c}) = 6.4 \pm 0.4 \text{ GeV}$$

### **Short-range correlations**

 $\delta_{12} = \langle \Psi | \delta^{(3)}(\mathbf{r}_{12}) | \Psi \rangle,$ 

needed, but its computation is difficult.

Possible way out: use a crude wave function with an improved matrix element. Schwinger rule and generalisations.

#### Idea:

A and  $A_B = A + [H, B]$  have same expectation value within any eigenstate of H.

A suitable choice of *B* might make  $\langle \Psi^M | A_B | \Psi^M \rangle$ converging faster than  $\langle \Psi^M | A | \Psi^M \rangle$  to the exact  $\langle \Psi | A | \Psi \rangle$ as the size *M* of the basis is increased.

#### 2-body:

 $A = \delta^{(3)}(\mathbf{r}) \to A_B \propto \mathrm{d}V/\mathrm{d}r$ 

For v(r) = r, perfect. Explains why  $\delta_{12}^n$  is the same for all *S*-states, independent of the radial number *n*. More general:  $\delta_{12}^n$  increases (decreases) with *n* if V'' > 0 (< 0).

Generalization: 3-body or N > 3

Additional (small) centrifugal term due to internal excitations. Used for parity-violation in atoms, annihilation of exotic molecules with positrons, and short-range correlations in baryons (hyperfine effects in Breit–Fermi models, decay properties). See: J. Sucher, Hoffmann-Ostenoff et al., Fleck + JMR, H.J. Lipkin, etc.

#### **Spin forces 3: LS and T**

Reasonably explained by spin-orbit and tensor forces.

$$V = V_{\rm ct} + V_{\rm LS} \, \mathbf{L}.\mathbf{S} + V_{\rm T} \, S_{12},$$

with  $V_{\rm ct}$  being the central-triplet potential, and  $S_{12} = 3 \,\boldsymbol{\sigma}_1 \cdot \hat{\mathbf{r}} \,\boldsymbol{\sigma}_2 \cdot \hat{\mathbf{r}} - \boldsymbol{\sigma}_1 \cdot \boldsymbol{\sigma}_2$ , one gets

$${}^{3}P_{m}^{pert} = \frac{{}^{3}P_{0} + 3 {}^{3}P_{1} + 5 {}^{3}P_{2}}{9}$$
$$\langle V_{LS} \rangle = \frac{-2 {}^{3}P_{0} - 3 {}^{3}P_{1} + 5 {}^{3}P_{2}}{12}$$
$$\langle V_{T} \rangle = \frac{5}{72} \left(-2 {}^{3}P_{0} + 3 {}^{3}P_{1} - {}^{3}P_{2}\right)$$

Table 1: Expectation values (in MeV) of spin-orbit and tensor potentials (assumed to be treated at first order) for the  $\ell = 1$  levels of  $c\bar{c}$  and  $b\bar{b}$ .

State	$\chi_c$	$\chi_b$	$\chi_b'$
$\langle V_{\rm LS} \rangle$	35	13	9
$\langle V_{\mathrm{T}} \rangle$	10	3	2

# Spin forces 4: $J/\Psi - \eta_c$

Earlier 300 MeV disturbing. Better understood at 117 MeV. Extrapolation to  $b\bar{b}$ : small, explains why  $\eta_{\rm b}$  not yet seen.

### Puzzling $\eta_{\rm c}^\prime$

Other problems with radial excitations: missing modes of  $\psi'$ , S–D orbital mixing, etc.

Perhaps  $\psi' - \eta_{\rm c}'$  very small, if

- \* J/ $\Psi \eta_c$  larger than pure chromomagnetic splitting, due to mixing with a glueball (Anselmino)
- ★ n = 2 chromomagnetic splitting only about 60% of n = 1.
- \* Mixing to  $D\bar{D}$ ,  $D\bar{D}^*$ + c.c. unfavourable. e.g;, in the Cornell model, as completed by Martin and J.M.R.,  $\psi' - \eta'_c$  receives about -20 MeV.

A word about S–D mixing in  $\psi''$ . "Closest neighbour" argument: 1D mixed mainly with 2S. May be also some 1S, due to the favourable node structure.

#### **Spin forces 5:** ${}^{1}P_{1}$ **state of** $c\bar{c}$

A naive  $\sigma_1 \sigma_2 V_{SS}$  associated with  $V_{SS} \propto \delta^{(3)}(\mathbf{r})$  gives  ${}^{3}P_{m} - {}^{1}P_{1} = 0.$ 

Experimental masses:  $h_c = 3526.1$ ,  ${}^3P_m = 3525.3$  MeV. See, however, other talks:  $h_c$  remains to be confirmed.

At this level, everything can contribute: details in non-relativistic reduction, higher-order QCD effect, etc. Also what is meant by centre of gravity of triplet states?

The usual  ${}^{3}P_{m}^{pert} = ({}^{3}P_{0} + 3 {}^{3}P_{1} + 5 {}^{3}P_{2})/9$  assumes a perturbative treatment of  $V_{LS}$  and  $V_{T}$ .

A non-perturbative treatment starts from

$$H({}^{3}\mathrm{P_{m}}) = \frac{H({}^{3}\mathrm{P_{0}}) + 3H({}^{3}\mathrm{P_{1}}) + 5H({}^{3}\mathrm{P_{2}})}{9}$$

From the variational principle

$${}^{3}P_{m}^{non pert} \ge rac{{}^{3}P_{0} + 3 \, {}^{3}P_{1} + 5 \, {}^{3}P_{2}}{9}$$

by a few MeV. Then my reading of data is

$${}^{3}\mathrm{P}_{\mathrm{m}}^{\mathrm{non \ pert}} - {}^{1}\mathrm{P}_{1} \simeq + \mathrm{a \ few \ MeV},$$
 (2)

## Conclusions

Many developments on few-body quantum systems stimulated by problems raised in quark models studies of hadron properties.

In particular:

- Level pattern of alkalin atoms
- Level pattern of muonic atoms
- Spectroscopy of Antiproton-Helium atomcules
- Systematics of short-range correlations
- Stability of 3-charge systems  $(m_1^+, m_2^-, m_3^-)$
- Stability of 4-charge molecules  $(m_1^+, m_2^+, m_3^-, m_4^-)$
- Relations between N-body and (N 1)-body energies (Hall–Post inequalities)

- etc.
