This offer could not be considered since it was not technically complete, but it is important to know that there could be a second player.

- c) The supplier may propose an alpha value, provided it is larger than 1.5. Tolerance during the production must remain between ± 0.1 from the nominal value.

Basic wire design



two stage re-stacking

1st stacking, elements with 367-1075 NbTi filaments in CuMn matrix and Cu or CuMn in the outer sheath, manufactured by **hot extrusion**

2nd stacking, performed by means of cold drawing.

Two stage restacking with cold drawing at the second stage

has been recently tested on other contracts with appreciable results **1 st generation**

no CuMn in the element outer sheath "A-like" according Wilson report

Transverse Resistivity



Wilson approach has been followed

Wilson has used the formulae computed by Duchataeu, Turck & Ciazynski, which assumed a four shell structure (left)

To take into account the more complex structure of our design, starting from the same physical assumptions, we have computed the **formulae for a 7 shell structure** (right).



We have also included the **eddy current loss in the Cu zone inside the wires,** which accounts for $20 \div 25$ % of the wire losses (previously not included).

Filamentary area

For the filamentary zone we have considered the Carr approach, with the

two extreme hypotheses of bad and good coupling.

-good coupling

The superconductor effectively acts a shortcut, reducing therefore the matrix resisitivity







Dynamic stability



The stability criterion seems satisfied

So the margin for stability seems comparable to the layouts envisaged by MNW in Rep 29. This issue was more doubtful in the first design (May '07)



Open issues



Cold drawing/extrusion

- -is it really realiable?
- -less bonding?, more prone to degrade at smaller twist pitch?

On the other hand, reportedly, cold drawing leads to:

- less sausaging
- smaller alpha variation along wire length

 $\boldsymbol{\rho}_t$ is now close (higher) to specs for 1st generation and 2 times higher for 2nd generation

Dynamic stability better than the first design

Issues related to coating not yet considered
