The study of the losses has allowed to calculate the losses in the conductors



- The losses are not constant during the ramp
- Losses are not constant also in the cross section

Power distribution in conductor @ Bo=1.5 T

[Peak power 2200 W/m³]



Power distribution in conductor @ Bo=4.5 T

[Peak power 1080 W/m³]



Assumptions in the study

- The study of the temperature distribution on the conductors has been carried out assuming:
- 1. 2-D only. In the coil-end region the losses in conductor are lower and the magnetic field is lower
- 2. The coolant temperature is constant in time and in the whole magnet: 4.7 K
- 3. Only the narrow side of conductor is cooled by the coolant
- 4. Losses in collar, yoke and beam tube are neglected (losses in collar and yoke in the 2D section are very low)

Zero order calculation of thermal gradient in the insulation:

Cooling of conductor only from <u>inner short side</u>.

• Kapton thermal conductivity *k* = 1.1 E-5 W/(K*mm)• Insulation thickness d = 0.125mm • Conductor width w = 15.1 mm W/m^3

• Average power in the 34th turn

$$\delta T = \frac{d \cdot w}{k} p = 0.26 \text{ K}$$

Consequently there is a strong motivation to perform a more accurate study about the real gradient

Temperature gradient in conductors

- The study of the temperature distribution on the conductors has been carried out for the following cases:
- 1. Steady state analysis with constant power at Bo=1.5 T
- 2. Steady state analysis with constant power at Bo=4.5 T
- 3. Transient analysis with initial temperature 4.7 K
- 4. Transient analysis with initial temperature from case 2
- 5. Transient analysis with initial temperature from case 1

The current sharing temperature $T_g(J,B)$ in principle can be calculated reverting the relation:

$$J_{c}(B,T) = J_{c}(@5T \& 4.2K) \cdot \frac{C_{NbTi}}{B} \left[\frac{B}{B_{C2}(T)}\right]^{\alpha_{NbTi}} \cdot \left[1 - \frac{B}{B_{C2}(T)}\right]^{\beta_{NbTi}} \cdot \left[1 - \left(\frac{T}{T_{C0}}\right)^{1.7}\right]^{\gamma_{NbTi}}$$

$$B_{c2}(T) = B_{C20} \left[1 - \left(\frac{T}{T_{C0}}\right)^{1.7}\right]$$

However this formula can not be easily reverted for the temperature.

For this reason it is easier to plot the critical current in conductor, and search the **minimum** value

Critical current density (A/mm²) in superconductor in steady state case with power @ Bo=4.5 T



$(J_{op}=1300 \text{ A/mm}^2)$

Conclusion: the minimum value of T_g (current sharing temp.) occurs at Bo-4.5 T and in the conductor with peak field.

TRANSIENT ANALYSIS:

Temperature evolution starting from T=4.7 K

In conclusion, the transient thermal analysis, gives the following temperatures for the 34th conductor at the end of ramp-up:

- With initial temperature 4.7 K T=4.78 K
- With initial temperature from steady state @ 4.5 T T=4.80 K
- With initial temperature from steady state @ 1.5 T T=4.82 K

These values are reasonable close each others, and the differences are at the limit of the calculation errors.

We can conclude that T=4.80 K + -0.02 K

In the analysis it has been neglected:

- 1. The very large thermal capacity of supercrit. He inside the conductor. It could modify the temperature evolution in transient analysis
- The surface thermal resistance between supercrit. He and kapton. This resistance can be estimated around 600 W/(m²K): the additional increase in temperature in the 34th cond. could be between 0.03 K and 0.05 K
- 3. The surface thermal resistance between kapton and copper
- 4. The additional cooling of collar through the yoke (it should be a small effect).

As consequence, in collaboration with CERN, an experiment has been settled, in order to measure the actual thermal exchange between the **conductors**, insulated with **kapton**, and the **supercritical helium**.

A stack of 6 cables (insulated with kapton, LHC lay-out) has been instrumented inside with thermo-couples in order to measure the temperature

The conductor can exchange heat only through the narrow side, as in the magnet

The sample was prepared and measured at CERN with **He-II** We measured it in *static* **supercritical** helium

The sample was measured in the following condition:

- 1. Without "external" compression of the stack
- 2. With compression of 50 MPa by means of a tool, in order to reproduce the same situation in the magnet

The first measurement without compression was decided because there was some doubts about damaging thermo-couples at 50 MPa Temperature drop between conductor and supercritical helium @ 4.2 K vs. the heat power generated in the conductors (the power density range corresponds to 1300-7000 W/m³)



Both the measurements give an *integral insulation* conductivity :

k = 0.019 W/(m*K)M. Sorbi

• The drop temperature is linear respect to the power, giving a constant *thermal conductivity*

•This measurement in *static* supercritical He gives a conservative value for the conductivity of kapton respect to a *flowing* supercritical He

• The measured conductivity includes the thermal resistance between kapton-He and kapton-cable

• The measured conductivity of kapton is a factor 1.9 larger than the value used in the calculation

• The thermal analysis can be considered quite **safe** for the most important parameter: **conductivity through kapton insulation**.

Conclusions:

From the thermal analysis:

• The *minimum* temperature margin occurs on the **34th conductor** of the magnet, at the **end of the ramp-up**

• At the end of the ramp-up, the 34^{th} conductor temperature is T-4.80 K +/-0.02 K i.e. **0.10 K** above the coolant temp.

• Because the current sharing temp. is Tg=5.69 K (non-linear iron) the actual temperature margin in 0.89 K +/-0.02 K

• Thermal conductivity measurements through the kapton confirm the validity of the analysis.
