SUBJECTS ALLOWED TO SUBMIT THE OFFER

The subjects referred to in art. 65 of Legislative Decree no. 36/2023, who are not in one of the conditions referred to in articles 94, paragraphs 1, 2, 5 and 6, 95, and 98 of Legislative Decree no. 36/2023, are eligible to submit quotation.

ADMINISTRATIVE AND ECONOMIC DOCUMENTATION

The offer and the documentation relating to the procedure must be submitted exclusively through the Telematic Platforms. The offer and accompanying documentation must be signed with a digital signature or other electronic signature qualified or advanced electronic signature, or, in the case of foreign economic operators, if it is not possible to use the digital signature, the offer can be signed with a holographic/autograph signature on a scanned document and accompanied by a copy of the identity document of the legal representative signed by the same. The administrative declarations are drawn up in accordance with the articles 19, 46 and 47 of the decree of the President of the Republic n. 445/2000. The documentation presented in copy is produced pursuant to Legislative Decree no. 82/05.

3. Technical Specifications (if applicable);
